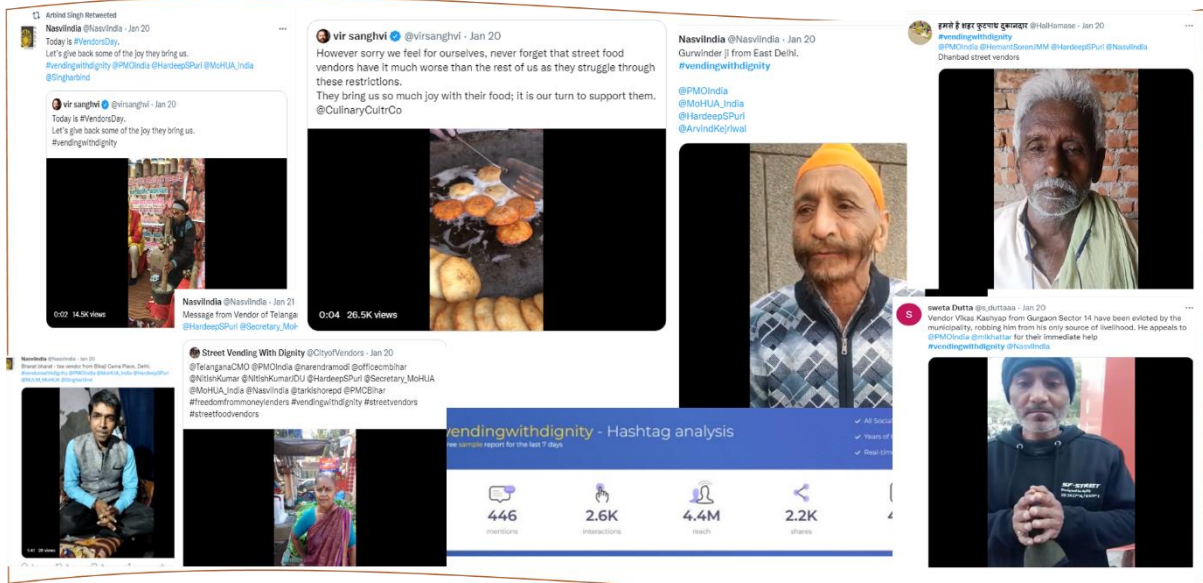

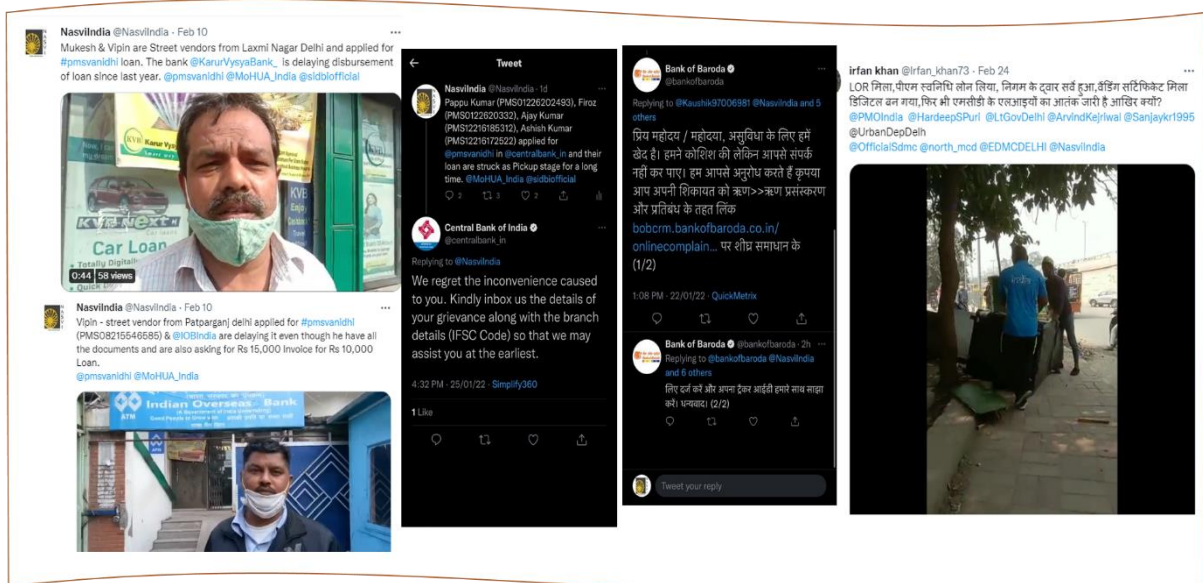

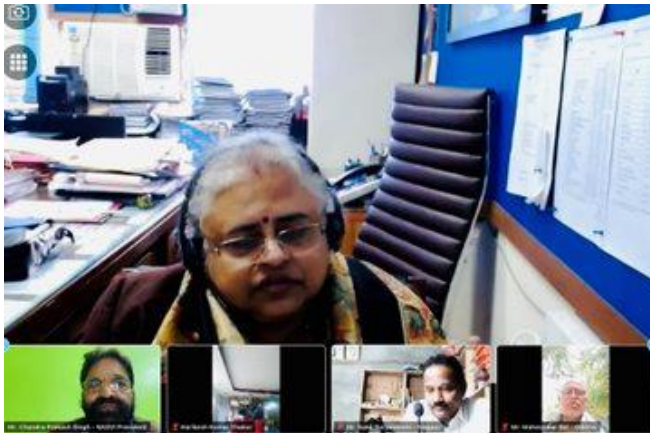

NEW DELHI Street vendors in New Delhi have filed a petition in the Supreme Court against the Delhi government for not implementing the Street Vendors Act, 2020. The petitioners seek the formation of a Town Vending Committee (TVC) as required under the Act. The court has directed the government to form the TVC within a specified period.

Third wave casts shadow on livelihood of street vendors

As much as 50% sale has come down, only 25% vendors have received second tranche of loan under the Pradhan Mantri Street Vendor's Allowance (PMSVA) Scheme. If State govt announces any restrictions, once again vendors' livelihood will be badly affected. They request State govt to support them through a few schemes.

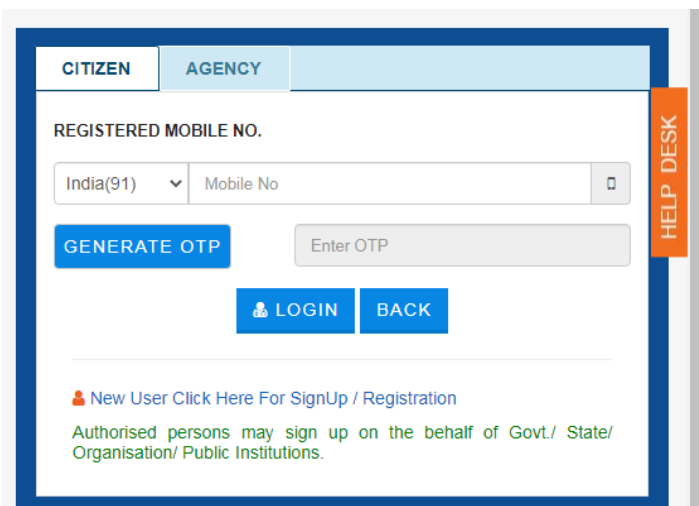

The goal of this workshop was to create a safe street food culture in India, as well as a community of empowered street food vendors.



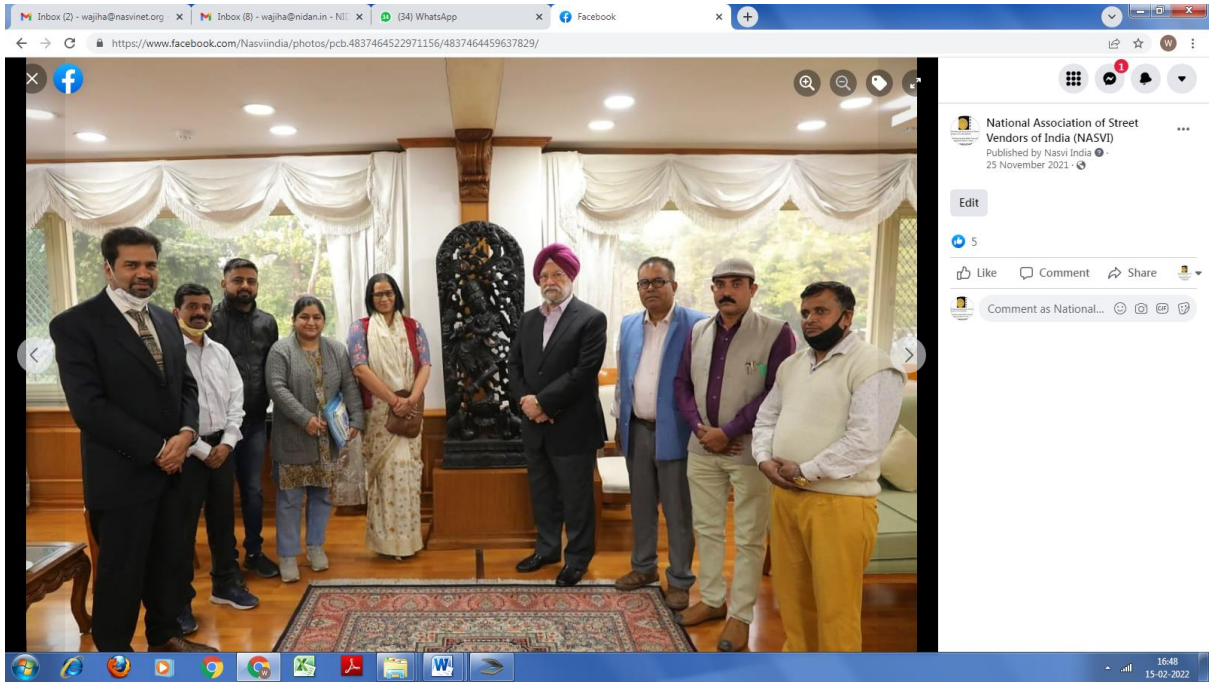
After continuous struggle of NASVI and the street vendors of Patna, Bihar, 13 Vending Zones and shelters were inaugurated in Patna.





Representatives of National Association of street vendors of India (NASVI) meets with with the Minister – Ministry of Housing and Urban Affairs – Shri Hardeep Singh Puri – and Joint Secretary – MoHUA – Shri Sanjay Kumar regarding harassment and turmoil among the street vendors across country. They demanded functional and Active Grievance Redressal Committee (GRC), survey of street vendors, Certificate of vending for all the surveyed vendors, elected TVC in every city and also discussed the issues with PM-SVANidhi Yojna. They also discussed the issues of vendors with BrihanMumbai Municipal Corporation (BMC) and New Delhi Municipal Committee (NDMC) poses serious threat to street vendors. Vendors of India Gate need to be integrated with Central Vista.

NASVI demanded that there are no Functional and Active Grievance Redressal Committee (GRC) as per the Street Vending Act - 2014. Even where GRC has been announced, it is not functional and only names of members has been made public. Shri Sanjay Kumar said GRC has been constituted in 7 States and Hon'ble MoS (I/C) has issued a letter to the UD ministers of all States/ UT for early constitution of GRCs. Shri Hardeep Singh Puri said he will take up the matter of harassment of street vendors to Home Ministry and an advisory will be issued by them so that street vendors will not be disturbed. He further added that list of street vendors having problem with PM-SVANidhi Yojna will be looked into and will be shared with financial institutions for necessary action. Regarding the survey of street vendors and certificate of vending, they will continuously pursue with the States for the survey and issuing of certificate of vending. He said all the Street vendors of NDMC and Mumbai will be covered in Municipality Survey. He will follow up with relevant stakeholders regarding the issues of street vendors of Mumbai.

बैठक में गिरिधर गौड़ चौपाल के अध्यक्ष, चौपाल से संगन कुजरी, मेन बजाज और सविन्दन चौक तक सड़क के किनारे फल सखी एवं अन्य पुटयाथ की दुकान लगाने पर पूर्णतः गैर सहाई ग्य है. इसके एखज में गिरिधर गौड़ चौपाल के समीप अंगनवाडी केन्द्र के बालन में फल - फलौी एवं दुकान लगाने को प्रयासिक अनुमती प्रदान की ग्य है. इन्हीं तहत पेटन चौक के इन्ड-मिन्ड छबीलपु गौड़ और शिखर गौड़ में होटल नालेन गिजैवे तक फल सखी एवं अन्य को दुकान सड़क किनारे लगाने पर गैर सहाई ग्य है. उनकी जगह किन्ना मिदान में फल को तहत फल सखी को दुकानें लगाती ऐगी. ब्रह्मकुंड क्षेत्र में सड़क के किनारे फल सखी एवं अन्य पुटयाथ दुकान लगाने पर गैर सहाई ग्य है. यह व्यवस्था ब्रह्मकुंड क्षेत्र से लेकर अन्वेइटर चौक को सड़कतुमंडल तक लागू ऐगी. इसके एखज में रजौने संगत में तत्काल अर्थाई रूप से पुटयाथ दुकानदारों को दुकान खोलने की व्यवस्था की जाएगी. चर्चा और बैठक के दौरान एसटीओ ने पुटयाथ दुकानदारों से के अन्वय विचार धारणी को बज कि वह सुनिश्चित करां कि गिरिधर गौड़ चौपाल पर सित पुटयाथ फल सखी विक्रेताओं द्वारा पुनः अतिक्रमण किञ्च ग्य है. शहर के बर्लक कार्यालय के भूत, गिरिधर गौड़ चौपाल के पास, सोबेन गौड़, मां लारवादी दुर्ग भवन के पास, छविलपु गौड़ एवं कुंड क्षेत्र में वेंडिंग जोन निर्माण हेतु विमर्श किया ग्य. बैठक बाद बैठक में शामिल अधिकारियों द्वारा प्रस्तावित स्थलों का निर्धारण किञ्च, निर्माण के दौरान एसटीओ द्वारा सीओ राजगीर की सची स्थलों की जमीन से संबंधित विस्तृत ब्योरा और उपलब्ध फाने का निर्दिष्ट किया ग्य है. इस बैठक में एसटीओ अर्चना सिंह के अलावे एसटीओ प्रदीप कुमार, डीपीएमओ एवं प्रवर्गी नगर अध्यक्ष पदविभक्तरी संजय कुमार, बीटीओ मिश्वलेन विकारी स्या, सीओ संतोष कुमार चौधरी, धनग्यथ दीशक कुमार, नगर प्रबन्धक राजगीर कुमार गुला, राजस्व कर्मचारी संजय कुमार किल और पुटयाथ दुकानदार संग के अध्यक्ष गोपाल भजनी शामिल हुए.
